QUEEN'S AWARD was unhurried into stride, took closer order between rivals through the turn, tipped out five wide entering the stretch, finished with a rush, reeled in MADAME Giry and was going away late. MADAME Giry settled in hand, split horses and angled out entering the stretch to make a bold bid, forged a late lead and kept on well but was out kicked. SWEET CASSIOPEIA was forwardly placed along the inside, shifted out leaving the turn, poked her head in front with a furlong to run, but weakened during the drive and settled for the show. SILVERETTE stalked the pace three wide, loomed a danger entering the stretch, but flattened between foes in the drive. MAGICAL MOON settled saving ground, angled out entering the stretch and finished with a belated gain between rivals. MAKING WAVES was hustled along in mid pack toward the inside, but lacked a response when called upon. BOUNDING BI sprinted clear to set the pace along the inside to the stretch and faltered. DENE COURT chased five wide, but came up empty midway through the turn and dropped out. TRIPPIN' ALONG broke outwardly to get away slowly and was never a factor. LIGNITE was close up along the inside early, then three wide before going a quarter, but stopped leaving the turn.
