GORMLEY sped to the early lead, set the pace along the inside, inched away again on the second turn and drew clear in the stretch under urging. KLIMT settled outside a rival, moved up off the rail on the second turn, came out some into the stretch, could not catch the winner but bested the rest. STRAIGHT FIRE kept a bit wide by the riderless horse nearing he first turn, stalked outside a rival then outside on the backstretch, moved up alongside a foe on the second turn, came out some in the stretch and clearly held third. MIDNIGHT PLEASURE pulled some and stalked a bit off the rail, fell back leaving the second turn and weakened in the stretch. VIBE angled in entering the first turn and stalked inside, dropped back leaving the second turn and also weakened. PLUM DANDY broke a bit slowly, saved ground, was in a bit tight into the first turn, chased inside, also dropped back on the second turn, came out into the stretch and gave way. SECRET HOUSE was fractious in the gate and had the rider step off as the gates opened. Following a stewards' inquiry into the break, SECRET HOUSE was declared a nonstarter.
