1 1/4 MILES. (1.422) STAKES. Purse \$300,000 *FLORIDA STALLION IN REALITY S. FOR TWO YEAR OLDS.* By subscription of \$2,500 each (Stallion); \$2,500 to pass the entry box and an additional \$2,500 to start. The added money together with all nomination fees, eligibility payments, entry and starting fees to be divided. Approximately 6.65% of gross purse October 13 after distribution of Stallion Nominator and Breeders' Awards. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Stallion and Breeders' Awards to be distributed according to Florida Statute in effect on the date of the race. Weight: 118 lbs. A trophy will be presented to the winning Owner. Nominations for Stallions closed on February 15, 2009 with 107 Stallion Nominations. (No Supplementary Nominations). Closed Friday, May 18, 2012 with 408 nominations. (Clear 78)

SPEAK LOGISTICS set the pace off the rail, increased his margin around the far turn, then was fully extended to remain clear to the wire.

TWO T'S AT TWO B taken in hand to stalk the pace three wide, couldn't gain on the winner in the drive while clearly second best. UPTOWN ANTHEM stalked the pace along the inside into the far turn and tired. JOSHUA'S COMPRISE unhurried after breaking slowly, passed tired rivals without threatening. C D GOLD up close early, raced three wide around the far turn and tired. DIXIE HIGH rated off the pace, raced three wide and faltered. HEAR ME COMIN was through after a half mile. D'NIED PERMISSION was done early. TIGER DISTINCTION reserved along the inside, faded leaving the far turn. BEACH MASTER was outrun.
