FOR FILLIES, TWO YEAR OLDS.* By subscription of \$2,500 each (Stallion); \$2,500 to pass the entry box and an additional \$2,500 to start. The added money together with all nomination fees, eligibility payments, entry and starting fees to be divided. Approxim ately 66.5% of gross purse October 13 after distribution of Stallion Nominator and Breeders' Awards. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to seco nd, 10% to third, 5% to fourth and 3% to fifth. Stallion and Breeders' Awards to be distributed according to Florida Statute in effect on the date of the race. Weight: 118 lbs. A trophy will be presented to the winning Owner. Nominations for Stallions cl osed on February 15, 2010 with 84 Stallion Nominations. (No Supplementary Nominations). Closed Friday, May 17, 2012 with 364 nominations. (Clear 87)

Dark Bay or Brown Filly, (Feb), by Act of Duty - Seductive Lady by Langfuhr. Trainer O'Connell Kathleen. Bred by Gilbert G. Campbell (FL).

SCANDALOUS ACT set the pace under pressure along the inside, then drew off when roused in the stretch. QUINNKAT reserved racing along the rail, advanced around the far turn to reach the attending position but was no match for the winner in the drive while proving best of the rest. HOLIDAY MAGIC stalked the pace off the rail into the stretch, then tired. FANTASTIC VOYAGE raced three wide and failed to menace. OLD WIVES TALE rated off the pace after being steadied entering the first turn, was through after six furlongs. GOLDEN FRIENDSHIPS moved up on the backstretch to press the pace outside SCANDALOUS ACT, then faltered in the drive. STARSHIP SASSY was done early. SOLITARY was caught in tight soon after the start, stalked the pace into the far turn and faded.
