Bay Colt, (May), by Gemologist - Gem Sleuth by Officer. Trainer Todd A. Pletcher. Bred by Fred W. Hertrich III & Ronald K. Kirk (KY). THEORY appeared to get away to a clean start, had the rider resort to a vigorous hand ride coming to the end of the backstretch, was switched

over to more patient handling after latching on to the pacesetter, this occurring at the midway point on the turn, whittled away at the advanage towards the two path, doing so against a rival being asked for a bit more than himself, took aim approaching the quarter pole, responded when put to a drive, arriving at the eighth pole in a practical dead heat with the nemesis, was in control soon afterwards, kicked away, set down to hand

encouragement with an occasional application of the stick from the left side thrown in. STAR EMPIRE (GB) took up the chase three to four wide on the turn, commenced the stretch more in the four path than before, failed to keep pace with the winner while rallying for place honors. MOVES LIKE ALI broke a length the fastest, was lightly hand urged to keep in front by that margin racing along the backstretch, had the winner draw alongside at the three-eighths pole, fended that foe off, placed to the same light hand ride as before, got set down for the drive home, yielded in midstretch then weakened into the show slot. THE WALK stumbled badly at the start, darted over to the inside, cut the corner under a drive, had no
