Supplemental nominations of \$1,000 will be accepted at time of entry which shall include all fees. \$75,000 Guaranteed of which 60% to the winner; 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to sixth through ninth. Weight: 122 lbs. Non-winners of \$45,000 since November 23, allowed 2 lbs, \$30,000 since October 23, 4 lbs, \$20,000 since then 6 lbs. (Maiden, claiming and starter races not considered in estimating allowances.) Starters to be named through the entry box by the usual time of closing. NOTE: This Stake will be limited to 14 starters should race not be split. High Weights will be preferred. Different owners have equal draw according to weii ghts.
