FOR FILLIES, THREE YEARS OLD.* Closes Thursday, February 14, 2007 with a fee of \$100, \$500 to pass the entry box and \$500 additional to start, with \$100,000 Guaranteed. (\$25,000 from the F.T.B.O.A. Stakes Fund to be divided, 60% to the winner, 20% to second 11% to third, 6% to fourth and 3% to fifth to Registered Florida Breds placing First, Second, Third, Fourth and Fifth.) The owner of the winner to receive \$45,000, \$15,000 to second, \$8,250 to third, \$4,500 to fourth and \$2,250 to fifth. Supplemental nominations may be made on Friday, February 23, 2007 at a fee of \$1,000, which includes entry and start fees. WEIGHT: 121 lbs. Non-Winners of \$36,000 once at a mile or over or two races other than Maiden or Claiming, allowed 2 lbs.; \$24,000 once at a mile or over or a race other than Maiden or Claiming, 4 lbs. Trophy to winning Owner. Closed Wednesday, February 14, 2007 with 21 nominations and 1 supplemental nomination. (If deemed inadvisable to run this race over the Turf course, it will be run on the main track at One Mile). (Cloudy 73)

DREAMING OF ANNA chased the pace, moved to take over on the far turn, responded when challenged by AUDACIOUS CHLOE, then dueled with that one and was outgamed to the wire. COMMUNIQUE reserved racing along the rail, rallied to be up for the show when unable to get to the top ones. DANTRELLE LIGHT well placed in behind the leaders, lacked a late response. BISHOP ESTATES off slowly, raced three wide around the far turn and failed to menace. FANLIGHT FANNY set the pace along the inside into the far turn, then tired. SUAVENESS was not a factor. GATORIZE raced four wide and faltered.
