**MOLLY MORGAN** stalked the pace early, angled off the rail into the far turn, took over command with a long drive in the stretch and prevailed late. **TAPIT'S WORLD** was unhurried early, shifted into the four path in the far turn, rallied through the turn, made a bid in the stretch with a long drive and just missed late. **LIVI MAKENZIE** set the pace early, was on the inside into the far turn and weakened late in the stretch run. **FRIVOLOUS** was well placed early, angled off the rail into the far turn, had no room through the stretch run and flattened out late. **INTEREST FREE** trailed the field early, swung into the six path in the far turn with a mild gain in the stretch. **OCEAN BERTIE** chased the pace early, shifted into the three path in the far turn and was empty late. **QUIET SUCCESS** fought restraint early and was through after a half. **LUCY'S REVENGE** was done early.
