JAVERRE , a forward factor three wide down the backstretch, advanced in the two path to engage IL VILLANO entering the stretch, gained a short lead near the eighth pole, opened up a clear advantage near the sixteenth pole and dug in under brisk urging. BRIGAND , behind IL VILLANO early, came out and bumped ASSOCIATE leaving the chute, hugged the rail around the turn, angled to the three path in upper stretch, remained on his left lead in upper stretch, switched to his right lead near the sixteenth pole and rallied. IL VILLANO broke alertly to gain the early lead, saved ground setting the pace, was pressed by the winner in upper stretch, remained in contention to midstretch then gradually weakened in the drive. BROAD RULE , unhurried outside horses down the backstretch, ranged up four wide around the turn, failed to menace the winner and finished willingly. FIDDLERS AFLEET , a forward factor early, was urged in the three path between horses on the turn, finished well but lacked the needed rally. ASSOCIATE , outside BRIGAND early, unseated his rider when soundly bumped by that one leaving the chute. Following a stewards' inquiry, BRIGAND was disqualified and placed fifth for impeding ASSOCIATE leaving the chute.
