MOONSHINE PROMISE raced in hand along outside while prompting the early pace, moved up to engage rival for lead three furlongs out, continued to stand strides with MY HOUSE into upper stretch then pulled away at furlong marker. MY HOUSE had slight lead coming out of the chute, continued on top under pressure from rivals throughout the backstretch, took on challenge of eventual winner three furlongs out, dueled along inside into head of the lane, could not move on approaching the eighth pole and held place in final strides. ROLL IT GAL was allowed to settle in the early going, picked up pace along outside running around the far turn, kept on with interest under stitched sticks in the lane and was getting to place in final strides. AIX EN PROVENCE saved ground along inside racing off the pace in early stages, came under a ride leaving backstretch, dug in two wide between rivals at five sixteenths pole then shifted out three wide, continued bid into lane then finished evenly. PRIMO VIA was placed back off the pace in the backstretch, continued off top two flights in the far turn, drifted out seven wide in the turn under right handed urging and had mild improve. COURTNEY RYAN was taken back at the start, allowed to settle throughout backstretch, urged for response along outside in far turn, raced eighth wide losing ground entering top of the lane, passed tiring rivals in drive. B L'S WAGON stalked pace racing two wide between rivals in early going, came under a ride at five sixteenths pole, failed to kick on and weakened in the lane. MISS DARLA was bumped at start, tracked pace at half mile marker then lost position, urged for response along outside in far turn, failed to move on. MIMI'S DREAM hustled up heading out of the chute, pressed pace along the inside, failed to sustain bid after the half, gawayay. SIXSPEEDOVERDRIVE raced evenly near back and never menaced. CONCEALEDWITHAKISS stalked pace along outside racing mid-pack in early going, failed to sustain bid after half and gawayay. DAKOTA EYES failed to respond.
