RACHEL ALEXANDRA sprinted clear, to set the pace, repulsed a bid by WAR ECHO on the backstretch, managed a small advantage on the second turn and drew off in the stretch under steady urging. SARA LOUISE within striking distance along the inside, moved off the rail on the backstretch, came around WAR ECHO entering the stretch to reach closest to the winner, could not run with that one but held on to be second best. WAR ECHO closest to the pace in the three path, challenged the winner before a half, prompted that one to the stretch and tired. DREAM EMPRESS outrun while off the inside, raced in the three path on the second turn when making a mild gain but could not menace. SUPER PONI behind the leader off the rail, tired. PEARL OF VALOR outrun early, raced five wide midway through the second turn and could not threaten.
