KATHMANBLU close up while relaxed three wide, challenged from that path when ready on the second turn, took over once in the stretch, drew off when roused and gathered up late. MISSYOULIKECRAZY closest to the pace off the inside, challenged between rivals on the second turn, could not run with the winner in the stretch but held on for the place. SUAVE VOIR FAIRE within striking distance four wide, maintained that path on the second turn and improved her position while no real threat. AIDE eager early when restrained and within reach of the leader, raced close up in the three path around the second turn and tired in the drive. GRAN LIONESSE sprinted clear and angled in, set the pace for nearly six furlongs, held on well to the stretch and tired. SWEET DEAL TO WIN unprepared at the start, was outrun for a half, raced off the inside on the second turn and was no factor. MISSED THE POINT lost her footing at the start, attempted to drift out on the first turn when restrained, held on well to the final quarter and gave way.
