BETTER BET angled in to press the pace on the outside around the first turn, took the lead leaving the half mile pole, opened a clear advantage on the second turn, drifted out in the late stages under left handed urging but gamely held for the score. ELECTRIC EDDIE saved some ground around the first turn, chased outside a foe on the backstretch, came into the stretch between horses, went after the winner but settled for second best. TAMARANDO was caught three wide into the first turn, chased off the rail down the backstretch, angled in entering the second turn, came out leaving the quarter pole, came into the stretch three deep, rallied in the final furlong to gain the show. CINMARS DANCE was four wide into the first turn, chased three deep on the backstretch, entered the stretch four deep, also rallied in the final furlong and was edged for the show. LIFE IS A JOY stumbled after the start, saved some ground around the first turn, was caught three deep on the second turn, came into the lane three deep and weakened in the late going. CALIFORNIA CHROME hopped at the start and was off slowly, chased inside a rival on the backstretch, came around a tiring foe entering the stretch and lacked the needed rally on the rally through the final furlong. GANGNAM GUY saved ground around the first turn, stalked in the clear down the backstretch and weakened between horses in the final furlong. SIR BARCLAY pulled in the early going, went into the first turn between horses, was again between foes on the second turn, swung out to enter the stretch five wide and weakened in the lane. TRIBAL MYSTIC sped to the lead into the first turn, set the pace on the inside, relinquished command to the winner leaving the half mile pole and gave way on the rail in the lane.
