REVERON prompted the pace outside NACHAS AND JOY, took over from that rival on the far turn, then responded when challenged by CASUAL TRICK entering the stretch and held that rival off in a game effort. CASUAL TRICK stalked the pace three wide, made a run to reach REVERON leaving the far turn, then tried that rival through the stretch but couldn't get by. KING KID stalked the pace along the inside, eased out for the stretch run and couldn't keep pace with the top ones. NACHAS AND JOY set the pace along the rail into the far turn, then tired. RAVELO'S BOY failed to menace and bumped with GOLD MEGILLAH on the far turn. SILVER MENACE off slowly, steadied in behind the leaders while headstrong around the first turn, tracked the pace to midway of the far turn, then faltered. POLITICALLYCORRECT raced five wide and faded. GOLD MEGILLAH was saving ground when he bumped with RAVELO'S BOY on the far turn and dropped back. REX'S LAST TOUR raced four wide and was through after six furlongs. ANCIENT ROME raced three wide and was done early. YOURHONORANDGLORY trailed.
