MUCHO MACHO MAN chased the pace off the rail, rallied to gain a slim lead at the quarter pole, then responded to pressure in the stretch and edged away. TACKLEBERRY quickly moved to the fore, set the pace along the inside, responded when headed by MUCHO MACHO MAN on the turn but couldn't stay with that rival in the drive while holding the place. JACKSON BEND threw his head at the start and broke slowly, stalked the leaders three wide around the turn, drifted out a bit in early stretch, then closed with a mild response. CAJUN BREEZE showed early foot along the rail, dropped back racing into the turn, then failed to menace thereafter. CLEAN SHOT chased the pace off the rail into the turn and faltered.
