ZULU hustled up at the start, dueled for early lead, continued to match strides along the inside of SHARP AZTECA around far turn, had more in reserve in upper stretch and began to move away from rival at furlong marker. SHARP AZTECA vied three wide for the early lead, continued to battle along outside of ZULU into the upper stretch, could not move on with rival in final furlong and finished second best. SPINTALK vied for lead in initial sixteenth then chased the top pair running around the far turn, could not reach the top two leaders in the lane and raced along for show. GOLD SHARK raced off pace in opening quarter, saved ground along inside, angled out at the quarter pole, raced four wide in the turn then angled in and finished evenly in lane. TWO TIMES BOOK was off step slow at start then rushed up along the rail, shifted out in the far turn, urged for response but failed to kick on. GRAND NENUCO raced back off the pace, gained position in the stretch but needed more to pose threat. MEGACOSM raced off top flight in early stages, urged for response three furlongs out, failed to sustain bid and giveaway. MAKES GOOD SENSE vied for lead in opening quarter, began to weaken after the half, kept along then giveaway. PERFECT CURLIN dropped far back after the start and never moved into contention.
