6th FURLONGS. (1:14²) STAKES. Purse \$100,000 Gulfstream Park Sprint S. (Grade III) FOUR YEAR OLDS AND UPWARD. Free nomination by Sunday, February 18. \$1,000 to enter. \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes since August 1 allowed 2 lbs.; a stakes race since August 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings. Trophy to the winning owner. (Clear 75)

CLASSIC ROCK broke well then brushed lightly and applied pressure to leader in opening stages, settled in tracking position and awaited cue in the turn, made smart move two path entering the lane, took command and quickly cleared on top, remained sharp and firm under steady encouragement. SWEETONHELADIES slightly bobbed then brushed at the start, raced widest and reserved in the back in early going, angled in leaving the backstretch and raced two wide through the turn, raced wide entering the lane, drifted wider before starting to move closer inside and rallied gamely. EIGHT TOWN was positioned well while rated near midpack in early stages, picked up the pace three furlongs out, raced in aim three path at the quarter pole, continued in striking distance upper stretch then was no match for pulling away winner, kept on with response racing three to four wide then got outkicked for place nearing the wire. MR. JORDAN came in and brushed rival at the start then moved to outside, continued wide near mid-range through the backstretch then made five move in turn, gained closer contention, fanned wider entering the lane then continued steady even bid to the end. UNBRIDLED OUTLAW tracked the top pair then launched bid leaving the backstretch and moved up to duel for the lead at the quarter pole, was no match for winner at three sixteenths pole then steadily weakened. FAVORABLE OUTCOME bobbed at the start then continued off the early pace, hustled up in the turn, showed interest three wide near furlong marker but needed more for impact. RICHARD THE GREAT raced four to five wide off early pace then sent driving along outside upper stretch without threatening. EXTRAVAGANT KID was away near the back then rushed into contention along the rail, retreated in the turn. ROCK AND FELLERS (ARG) gained the lead steps after the start from outside position, angled closer inside while under early pressure from eventual winner then cleared on top, challenged at the quarter pole then came up empty top stretch. NOHOLDINGBACK BEAR got brushed between step after the start then dropped to last after opening quarter and took no part.
