**MUNNINGS** pressed the pace outside **BIKER BOY**, moved to take over from that rival nearing the eighth pole, then was all out to prevail. **CONGRESSIONAL PAGE** chased the pace four wide around the turn, was outmoved by the leaders in early stretch, then responded to pressure and was gaining on the winner late while edging **MOTOVATO** for the place. The latter, outrun after breaking in the air, raced five wide around the turn and rallied to just miss the place. **INKADO** chased the pace along the rail, dropped back in early stretch, then finished willingly while just being edged for the place and show. **BIKER BOY** showed speed along the inside, responded when challenged by **MUNNINGS** on the turn, then was steadied to avoid coming out into that same rival inside the eighth pole and gave way. **PRESTO CHANGE O** raced with the pace three wide to nearing the stretch, then weakened. **YOU AND I FOREVER** rated off the pace, made a run five wide to join the leaders on the turn, then tired. **PEACE CHANT** was not a factor. **SOLAR FLARE (ARG)** broke a step slowly, saved ground around the turn and faltered.
