1 1/4 MILES. (Turf) (1.442) STAKES. Purse \$300,000 *GULFSTREAM PARK TURF H. (GRADE I) FOR FOUR YEAR OLDS AND UPWARD.* By subscription of \$300 each by Saturday, January 28, 2012, which shall accompany the nomination, \$3,000 to pass the entry box and \$1,500 additional to start, with \$300,000 Guaranteed. All fees shall be paid before the start of the race. Supplementary nomination by Noon Friday February 3, at a fee of \$15,000 which includes entry and starting fee. The owner of the winner to receive \$180,000, \$60,000 to second, \$30,000 to third, \$15,000 to fourth, \$9,000 to fifth and \$6,000 to sixth. Weights: Saturday, February 4, 2012. This race will be limited to 14 Starters, with Also Eligibles. High Weights Preferred with second preference to horses with the highest lifetime earnings. Starters to be named through the entry box by the usual time of closing. In the event this stakes is taken off the turf, it may be subject to downgrading upon review by the Graded Stakes Committee. Trophy to the winning owner. Nominations Closed Saturday, January 28, 2012 with 21 Nominations. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Eighth) (Rail at 72 feet). (Clear 70)

GET STORMY set the pace along the rail into the stretch, then was fully extended hold off HOLLINGER. The latter, reserved racing along the inside, eased out in the stretch and was gaining slowly on the winner at the finish. BIG BLUE KITTEN allowed to settle, swung out for the stretch run and closed with a mild rally to gain the show. YUMMY WITH BUTTER unhurried after being checked from between rivals in the early going, saved ground and failed to menace. KINDERGARDEN KID was not a factor. YANKEE FORTUNE tracked the leaders to nearing the stretch, then tired. SILVER MEDALLION chased the pace outside GET STORMY to nearing the top of the stretch and faltered. THE RIDER OF YUMMY WITH BUTTER LODGED AN OBJECTION AGAINST THE RIDER OF GET STORMY FOR ALLEGED INTERFERENCE IN THE EARLY GOING. THE CLAIM OF FOUL WAS NOT ALLOWED.
