(GRADE III) FOR FOUR YEAR OLDS AND UPWARD.* By subscription of \$100 each by Saturday, December 20, 2008, which shall accompany the nomination, \$1,000 to pass the entry box and \$1,000 additional to start, with \$100,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$60,000; \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to sixth. Supplemental nominations may be made on Wednesday, December 31, 2008 at a fee of \$4,000, which include entry and starting fees. Weight : 122 lbs. Non-winners of a graded/group sweepstakes allowed 2 lbs.; of a sweepstakes 4 lbs., of two races other than maiden or claiming at a mile or over in 2008 6 lbs. Starters to be named through the entry box by the usual time of closing. This race will be limited to 14 Starters, with Also Eligibles. DELIGHTFUL KISS outran after breaking slowly, swung wide for the stretch run, rallied to gain command inside the eighth pole and won going away. BULLSBAY rated off the pace, swung out for the stretch run and closed to be up for the place while no match for the winner. FAMOUS PATRIOT chased the pace into the stretch and closed to be up for the show while being outfinished by the top ones. ANAK NAKAL unhurried after breaking slowly, swung wide for the stretch run and finished willingly. FEARLESS VISION chased the pace along the rail, bobbed in behind FINALLYMADEIT soon after entering the turn, made a run inside that rival to loom a threat at the eighth pole, then weakened. IT'S A BIRD allowed to settle, angled out for the drive and passed tired rivals. CUBA failed to menace. FINALLYMADEIT set the pace along the inside, came out a bit for the stretch run and gave way. NATIONAL PRIDE tracked the pace three wide around the turn and had no response when asked. BRIBON (FR) chased the pace three wide, made a run to reach near even terms for command at the quarter pole, then fired in the drive. TRUE RESURGENCE was not a factor. NOW A VICTOR chased the pace, made a run to try FINALLYMADEIT around the turn, then faltered. REXSON'S ROSE saved ground and faded. STORM IN MAY raced four wide and was done early.
