1 MILE. (1:33) STAKES. Purse \$100,000 Hal's Hope S. (Grade III) FOUR YEAR OLDS AND UPWARD. Free nomination by Sunday, February 10. \$1,000 to enter. \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes at a mile or over since August 1 allowed 2 lbs.; a stakes at a mile or over since August 1, 4 lbs.; three races other than maiden, claiming, or starter, 6lbs. Starters to be named by usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. Preference will be given to graded stakes winners, then by highest career earnings. (Cloudy 82)

PRINCE LUCKY vied for the lead coming out of the chute then edged back to track top pair racing in striking range, settled nicely then let out a notch and edged up to race on equal terms with COPPER TOWN mid-way through turn, continued to battle into stretch then gained advantage at furlong marker, had more in reserve and continued to widen advantage to easy victory. COPPER TOWN bobbed at the start but sharp and near lead stride after, vied for the lead coming out of the chute then held slight edge over QUIP, dueled for the lead at the half mile marker, continued to battle into far turn, began to move away from QUIP while taking on PRINCE LUCKY, continued to battle back along inside of rival into stretch, could not match past the furlong marker, kept along for second best. QUIP dueled for the lead coming out of the chute then COPPER TOWN briefly held slight edge before inching way up to duel on equal terms, continued to battle into far turn, could not match strides past the three eights pole, angled out and kept along for share. TALE OF SILENCE was allowed to settle out of the gate, continued unhurried saving ground and along the rail through turn, angled out turning for home, raced three to two wide and improved position. SIR ANTHONY raced off the pace, made two wide bid in the turn, gained position then finished evenly. FELLOWSHIP raced off the early pace, hustled up at three eights pole then raced four wide at quarter pole, five wide into stretch and lacked late needed response. MR. JORDAN raced in range then lost kick late backstretch and faded through the turn. BREAKING LUCKY showed early response not far off pace then came up empty and retreated in the turn.
