1 1/4 MILE. (1:40+) STAKES. Purse \$100,000 Harlan's Holiday S. THREE YEAR OLDS AND UPWARD. Free nomination by Sunday, December 4. \$750 to enter and \$250 to start. \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: Three Year Olds: 120. Older: 123 lbs. Non-winners of a graded stake at a mile or over since June 1 allowed 2 lbs.; a stakes race at a mile or over since June 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at the time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings. Trophy to the winning owner. (Cloudy 80)

STANFORD broke on top and quickly took over the lead, continued controlled tempo on top throughout the backstretch, asked for more at head of lane, came under right handed urging, kicked away to clear lead and finished ridden out. KEEN ICE was allowed to settle in early stages, picked up the pace leaving the backstretch, commenced four wide bid approaching the head of the lane, roused three deep then two wide, could not reach eventual winner but dug in and edged rival for place. AWESOME SLEW raced in contention tracking the pacesetter, roused between rivals at head of the lane, could not reach eventual winner but dig in for place and got edged for position in final strides. MADEFROMLUCKY secured inside position in the first turn, stalked throughout the backstretch, continued up close position, dug in along rail at head of the lane then evened out. HY RIVERSIDE was unhurried and raced in then near the back, picked up the pace in the far turn, continued outside bid into the lane, showed response but was not enough for late impact. JOSHUA'S COMPRISE raced in bit tight along the rail in the first turn, continued to pull slightly racing along the rail in early backstretch, raced in the back, came under a ride but failed to move on. APPLICATOR bobbed at the start then raced in up close position, could not keep up pace after the half, dropped back, eased up in the lane and walked off after the race.
