DAYATTHESPA chased the pace off the rail, moved to take over entering the stretch, then was all out to last over. REGALO MIA allowed to settle, saved ground, angled out in early stretch, then rallied to just miss. ALMUSAFA rated off the pace, swung out at the top of the stretch impeding NORTHERN PASSION, then closed to gain the show while no threat to the top ones. DIXIE STRIKE un hurried after breaking slowly, passed tired rivals in the drive. WHOLEOTTASHAKIN stalked the pace three wide into the stretch and tired. NORTHERN PASSION reserved in striking position off the pace, steadied at the top of the stretch when ALMUSAFA swung out in front of her and failed to recover. FROLIC'S REVENGE set the pace along the rail to nearing the stretch, then faltered. ANN OF THE DANCE well placed into the far turn, faded. FOLLOWING A STEWARDS INQUIRY, ALMUSAFA WAS DISQUALIFIED AND PLACED SIXTH FOR INTERFERENCE TO NORTHERN PASSION AT THE TOP OF THE STRETCH.
