COURT VISION settled inside then a bit off the rail, came three deep into the stretch and rallied under urging to be along in time. COWBOY CAL stalked the pace outside a rival or off the rail, continued outside a foe leaving the second turn, bid three deep in the stretch and continued willingly between horses late. MIDSHIPS was in a good position chasing the pace three deep to the stretch and finished with interest. DIXIE CHATTER pulled his way along and stalked the pace inside, bid along the rail in the stretch and was outfinished. MUNY took the early lead and angled in, set the pace along the inside, came a bit off the rail in the stretch, fought back between horses in the final furlong and continued willingly to the wire. ALBAHRI (FR) a bit slow to begin, angled in and saved ground chasing the pace and could not summon the necessary late response. GIO PONTI chased between horses or a bit off the rail to the stretch, lacked room off heels from midstretch to deep stretch and was in close behind rivals to the wire. MADEO in a good position chasing the pace between horses to the stretch, waited off heels in the stretch and lacked the needed rally. SAILOR'S CAP stalked the pace three deep to the stretch and weakened.
