Closed with 21. All nominees to pay \$1,000 to enter and an additional \$1,000 to start. Gross purse \$150,000 of which \$90,000 to be paid to the winner, \$30,000 to second, \$18,000 to third, \$9,000 to fourth and \$3,000 to fifth. A trophy will be presented to the winning owner. es the right not to divide this race. Should this race not be divided and the number of entries exceed twelve (12), highweights on the weight scale will be preferred. Total earnings in 2008 will be used in determining the order of preference of horses assigned equal weights on the scale. Entry fees will be refunded to all horses which fail to draw into this race. CALIFORNIA FLAG sped to the early lead, angled in and set the pace a bit off the rail, kicked clear inside on the turn, was mildly hand ridden to widen the advantage in the stretch and proved best without further encouragement. RACKETEER settled a bit off the rail, went outside a rival on the turn, came out in the stretch and gained the place late. DELTA STORM stalked inside, came out into the stretch, split rivals in the drive and was edged for second. CARRILERO (ARG) chased outside a rival then a bit off the rail, swung three deep into the stretch, went between rivals in late stretch and just missed the show. ONE UNION pulled his way along to stalk between horses, angled in on the turn and weakened in the final furlong. JOE BRAVO (BRZ) close up stalking the winner three deep on the backstretch and into the turn, angled in outside a rival leaving the bend and also weakened. UNUSUAL SUSPECT settled off the pace inside, came out into the stretch and did not rally.
