STORMIN NORMANDY was hustled out to a clear lead, set the pace along the inside, drifted out badly through the stretch run and lasted after a stiff drive. FEROCIOUS FIRES was pinched back after the start, raced between rivals, rallied wide and finished gamely while being carried out in the stretch run. I'M A NUMBERS GUY chased the pace while between rivals and weakened in the final furlong. GOLD AND ROSES was outrun early, rallied four wide approaching the stretch and had little left for the stretch drive. MONSTER DRIVE was hustled along inside, chased the pace and had no response when roused. EXECUTIVE SEARCH was outrun early, came wide into the stretch and offered a mild rally outside. INTROSPECT chased the pace while between rivals and tired in the stretch. POSTED chased the pace while three wide and tired after a half mile. LONG LOST PAL tired badly and was eased in the stretch. Following a Stewards' inquiry concerning the stretch run, STORMIN NORMANDY was disqualified from first position and placed second for causing interference in the stretch.
