CARINA MIA chased the pace early along the eight path, was in the seven path entering the lane, made a bid in the stretch three wide but did not have enough in the late stages. SWEETGRASS was unhurried early while off the rail, shifted into the four path in the turn with some gain in the stretch run. LIGHTSTREAM raced back early on from the six path, stayed in the six path entering the lane with a minor gain in the stretch drive. MINES AND MAGIC was well placed early along the four path, went into the five path in the turn and faded late in the stretch. SUPER HUMOR set the pace early from the three path, stayed in the three path entering the lane and gave way in the stretch.
