1 1/4 MILES. (1.404) STAKES. Purse \$250,000 IOWA DERBY (GRADE III) FOR THREE-YEAR-OLDS. Weights: 122 lbs. Non-winners of \$50,000 at a mile or over in 2010 allowed 3 lbs., non-winners of \$40,000 in 2010 allowed 6 lbs., non-winners of \$20,000 in 2010 allowed 9 lbs. No nomination fee. \$1,000 to pass the entry box and \$2,500 additional to start. \$250,000 guaranteed of which 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$5,000 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds fourteen (14), high weights will be preferred. Different owners will have equal draw according to the weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. (Clear 88)

CONCORD POINT stalked the early pace from the three path, crept close up the backstretch, reached a striking position entering the second turn, took command on the turn and steadily drew clear while lightly roused. THISKYHASNOLIMIT unhurried early, advanced outside up the backstretch, reached a forward position entering the second turn, responded when asked but was no match for the winner. WINSLOW HOMER well placed early while inside rivals, chased the pace up the backstretch, remained forward entering the second turn but could not keep pace. DOWN WITH DIXIE outrun early, advanced inside entering the second turn but could only improve position. VOW TO WAGER pressed the early pace from the inside but had no late response. FORESTRY TYPE broke sharp from the outside, gained a clear early margin, remained clear up the backstretch but tired in the drive.
