1 1/4 MILE. (1:40) STAKES. Purse \$250,000 Iowa Derby FOR THREE-YEAR-OLDS. Weights: 122 lbs. Non-winners of \$50,000 at a mile or over in 2019 allowed 3 lbs., non-winners of \$40,000 in 2019 allowed 6 lbs., non-winners of \$20,000 in 2019 allowed 9 lbs. No nomination fee. \$1,000 to pass the entry box and \$2,500 additional to start. \$250,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$5,000 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds fourteen (14), high weights will be preferred. Different owners will have equal draw according to the weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. (Clear 80)

WINNING NUMBER seized command from the outset, held well into the stretch, responded, came in under stiff right-handed pressure approaching the sixteenth pole and edged clear late. TOP LINE GROWTH squeezed at the start, settled while three wide, advanced on the far turn, went three wide into the stretch and finished well. SHANG reserved, was angled in on the far turn, offered a rail bid, was shut off at the sixteenth pole, checked and stumbled as a result, maneuvered out and kept on. FLUMINENSE checked in the early going, was taken in hand, commenced his bid on the far turn, rallied while three wide and made a belated bid. NIGHT OPS was outpaced while three wide and lacked a rally. MR MONEY BAGS raced forwardly while four wide, moved closer on the far turn and came up empty. AND SEEK stalked the pace, raced in tight quarters at the quarter pole, was checked and could not recover. MILFON TOWN outpaced early, lodged a brief bid on the far turn and flattened out. THE TRASHMANS COMING dropped back early and trailed the remainder. FOLLOWING THE RACE, THE STEWARDS POSTED THE INQUIRY SIGN TO EXAMINE TWO INCIDENTS, IN ADDITION, THE RIDER OF SHANG FILED AN OBJECTION ALLEGING INTERFERENCE AGAINST THE RIDER OF WINNING NUMBER. AFTER REVIEWING VIDEOTAPED REPLAYS, THE STEWARDS DISQUALIFIED WINNING NUMBER AND PLACED HIM THIRD. SECOND PLACE FINISHER TOP LINE GROWTH WAS PROMOTED TO FIRST PLACE.
