GIBSON showed speed off the rail into the stretch, then increased his margin to the wire under urging. PASHITO THE CHE was chasing the pace along the inside when steadied from tight quarters entering the turn, angled out for the stretch run and closed to be up for the place while no threat to the winner. RIBO BOBO reserved early, saved ground around the turn and closed to gain the show. ONESTEPTOGO angled in racing down the backstretch bumping BULL DOZER soundly, chased the winner three wide into the stretch, then tired. PEACE AT DAWN failed to menace. BLACK DIAMOND CAT raced three wide and faltered. BULL DOZER was knocked sideways by ONESTEPTOGO on the backstretch, chased the pace around the turn, then faded. ROYAL TRICON unhurried early, broke down on the turn and was pulled up. FOLLOWING A STEWARDS INQUIRY, ONESTEPTOGO WAS DISQUALIFIED AND PLACED SEVENTH FOR INTERFERENCE TO BULL DOZER ON THE BACKSTRETCH.
