BRAVE DAVE took control soon after the start, was a bit rank out of the chute when slow to settle, showed the way up the backstretch and through the turn in hand, set down for the drive, drifted, all out to hold the runner up safe late. SR. QUISQUEYANO brushed start, raced closest to the winner to that one's outside, fell back a bit through the turn, roused with a quarter mile remaining, slowly gaining late while remaining out in the strip. UPTOWN ANTHEM broke in, brushed with TOO FAST TO PASS at the start, raced back, along for the show while not a threat to the top pair. BEACH MASTER within striking distance outside, came four wide when beginning to fall off the top two into the lane, had little left and was outfinished for the show spot. TRIP N RUN fell back after the start, was never a threat. TOO FAST TO PASS in tight at the start, asked a bit early in an attempt to keep up, fell back to trail in the turn and was finished.
