The latter, reserved off the pace, raced four wide around the turn, then responded to pressure in the drive and rallied to just miss. YESBYJIMMINY vied for the lead along the rail to inside the eighth pole, then gave way. JAMES WILFRED unhurried early, saved ground around the turn and improved his position without threatening. DIPPI TRIPPI chased the leaders three wide into the turn and tired. POP GOES THE TIGER tracked the leaders into the turn and faltered. CAPTAIN CAMERON was no factor while racing three wide. DREAM AMERICA was outrun. OUR FRIEND HARVEY chased the pace along the inside into the turn, faded and was eased in the final eighth.
