1 MILE. (Turf) (1.332) STAKES. Purse \$100,000 JAMES W. MURPHY S. FOR THREE-YEAR-OLDS.
By subscription of \$100. \$500 to pass the entry box, \$500 additional to start, with \$100,000 Guaranteed, of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Supplemental nomination of \$1000 each will be accepted by the usual time of entry with all other fees due as noted. Weight 122 lbs. Non-winners of \$60,000 at one mile or over, allowed 2 lbs.; \$50,000 at one mile or over, 4 lbs.; \$40,000 at one mile or over, allowed 6 lbs. (Maide n, Claiming and Starter races not considered in estimating allowances). Trophy to the owner of the winner. Nominations closed Tuesday May 8, 2012 with 39 nominations. (If deemed inadvisable by management to run this race on the Turf course, it will be run on the main track at One Mile and One Sixteenth). (Clear 82)

SKYRING sped to the front, set the pace slightly off the rail, was challenged by HAMMERS TERROR leaving the far turn, dueled through the stretch, dug in determinedly and narrowly prevailed. EASY CROSSING , rated between horses, was in the two path between horses on the far turn, eased out four wide at the head of the stretch and rallied late. MR. HANDSOME saved ground in a stalking position, was in narrow quarters leaving the far turn, altered course to the three path in midstretch and closed gamely between horses. HAMMERS TERROR , bumped leaving the starting gate, was three wide both turns, bid for the lead entering the stretch, dueled through the lane and weakened late. TWO MONTHS RENT drifted out leaving the starting gate, left the far turn in the five path, was lightly steadied in upper stretch then passed tired rivals. SHAKSPERE SHALIYAH lacked speed, hugged the rail turning for home, had a mild advance to midstretch then failed to sustain his move. DONE TALKING , in the two path entering the stretch, came up empty. ADIRONDACK KING drifted in leaving the starting gate, was four wide the first turn and gave way in upper stretch. GOLD MEGILLAHL , bumped leaving the starting gate, circled the first turn three wide, hugged the rail in the stretch and failed to be a factor. LEMON JUICE , well off the rail, chased the pace to the stretch then faltered. An objection by the rider of MR. HANDSOME against the winner for alleged interference near the quarter pole was not allowed.
