**EIGHTTOFASTTOCATCH** advance inside rivals and took over heading towards the three quarter pole, shook clear a furlong later and dictated the pace under a light hold and off the inside, turned away a threat from **LARRY LE ROI** in upper stretch and pulled away under relentless right handed encouragement. **LARRY LE ROI** followed the winner up the inside early and stalked the pace, angled out mid turn, loomed four wide in upper stretch, gave hard chase past the eighth pole, flattened out late but did manage to save the place. **CONCEALED IDENTITY** , brushed and pushed out a bit at the break, was angled in early and taken to rate, picked up some momentum leaving the three eighths, got through inside in upper stretch and kept on with some interest. **TURBIN** came out at the break and brushed with **CONCEALED IDENTITY**, rushed up after being corrected and stalked the pace, was under a ride three to four wide chasing past the three furlong marker and faded. **ALWAYS SMILING** , three wide between rivals near the half mile pole, was under pressure around the turn, came five wide for the drive and had a mild late response. **KOH I NOOR** vied outside the winner past the three quarter pole, could not math strides leaving the far turn, chased and faltered. **OUTBACKER** , between horses while off the pace, failed to menace. **CURLIN'S KID** , four to five wide while between horses, exchanged bumps with **D C DANCER** and gave way. **D C DANCER** , five to six wide while off the pace, had his rider briefly lose his balance near the half mile pole when bumping with **CURLIN'S KID**, failed to respond and retreated.
