SOMALI LEMONADE was unhurried into stride, settled in hand, responded when roused with five-sixteenths to run, swung to the outside entering the stretch, reeled in SWEET CAT inside the furlong marker and edged clear. SWEET CAT stalked the pace three wide, launched a bold bid leaving the second turn, shook clear with a furlong to run but was unable to resist the winner. EMERALD GOLD was allowed to settle, advanced between horses, shifted out entering the stretch but was outfinished through the drive. SPRING ECLIPSE tucked in to save ground, angled out off of the inside, moved with the winner between rivals through the second turn, came three wide and improved position. GRACE FOR GRACE was hustled along five wide while never far back, but flattened between horses in the stretch and faded. FALCONESS set the pressured pace, opened clear after a half, was headed leaving the second turn and gave way readily thereafter. HONEY TALK tracked three wide, came four wide but lacked a response when called upon. QUICK SILVER SONG settled between horses in mid pack and failed to respond. SOONERETTE tracked the pace three wide, drew even midway through the second turn, but came up empty between horses in the drive and faded. PISKACHA showed little. CHARMING VIXEN was close up along the inside to the second turn and dropped out. BLESS MY HALO was through early, was taken up late and eased to the wire but walked off.
