KITTEN KABOODLE attended the pace along the inside, got through entering the stretch, struck the front nearing the furlong marker and kicked clear. ZINZAY settled in hand four wide, moved with the winner through the second turn, lost momentum entering the stretch when carried out, leveled back into stride quickly and continued on well for the place. COURTESAN settled saving ground, tipped out and advanced between horses through the second turn, bumped repeatedly with RUNWAY GIANT through the stretch but kept on willingly. CANDY KITTY was allowed to settle, came four wide to make a mild bid, but toiled through the drive and failed to seriously threaten. RUNWAY GIANT broke outwardly, tucked in and was unhurried into stride, made a mild rally five wide entering the stretch, bumped with COURTESAN through the drive but improved position. ZIP ON sped clear to set the pace off of the inside, veered out entering the stretch into the path of RICHIES PARTY GIRL nearing the three-sixteenths pole, was straightened away but faltered in the final furlong. ACADEMIC PROBATION broke slow, was unhurried into stride, swung to the outside entering the stretch and finished with a belated gain. SHANON NICOLE saved ground to little avail. PRETTY FANCY was away slow, moved up between horses, came three wide, but came up empty entering the stretch and retreated. RICHIES PARTY GIRL was close up three wide, was forced out entering the stretch when ZIP ON came out, altered course out further and gave way readily thereafter.
