DANCING EDIE took the early lead and came a bit off the rail leaving the chute, set the pace just off the inside, fought back on the second turn and between rivals through a long drive, drifted out a bit late to brush with ISLAND FASHION in late stretch, was narrowly headed nearing the wire but gamely prevailed under urging. MOSCOW BURNING saved ground stalking the pace, bid inside in the stretch, put a head in front in deep stretch and continued willingly to just miss. ISLAND FASHION stalked outside a rival or off the rail, bid alongside the winner into and on the second turn and three deep into the stretch, brushed with the winner and was forced out a bit in deep stretch but went on gamely to the end. AMORAMA (FR) chased a bit off the rail, came out in midstretch and closed gamely four wide on the line. MEMORETTE chased outside a rival, came out four wide into the stretch and continued willingly but was outfinished. LIVE LIFE (FR) bobbled slightly in a bit of a slow start, chased outside a rival then three deep into and on the second turn and lacked the needed rally. KATDOGAWN (GB) saved ground chasing the pace, moved up inside leaving the backstretch then fell back again early on the second turn, came out in the stretch and could not offer the necessary response. The stewards conducted and inquiry into the stretch run between the winner and ISLAND FASHION but made no change when they ruled both runners contributed to the contact between them.
