


Dark Bay or Brown Filly, (Mar), by War Front - Lerici by Woodman. Trainer Richard E. Mandella. Bred by Lerici Syndicate (KY).

AVENGE angled in and pressed the pace outside a rival, took the lead into the stretch, kicked clear toward the inside and held on gamely under urging. FINEST CITY stalked between horses, bid four wide between foes into the second turn, came three wide into the stretch and came back on between foes late. ELEKTRUM (IRE) chased outside a rival then three deep, came five wide into the stretch and closed willingly. KERI BELLE angled in and settled outside a rival, came out leaving the second turn, swung four wide into the stretch and found her best stride late. SOBRADORA INC (ARG) chased a bit off the rail then inside, continued between rivals on the second turn and three wide into the stretch and was outfinished. HAVANNA BELLE (IRE) angled in and chased outside a rival then between foes on the backstretch, continued a bit off the rail leaving the second turn, waited briefly off heels in midstretch then got through inside. QUEEN OF THE SAND (IRE) saved ground stalking the pace, came out in upper stretch and lacked the needed rally. GLORYZAPPER sped to the early lead, set a pressured pace inside, fought back on the second turn, came a bit off the rail in the stretch and weakened between foes late. PERSONAL DIARY angled in and settled off the pace inside, came out into the stretch and could not offer the necessary response. PRIZE EXHIBIT (GB) stalked the pace three deep, bid five wide into the second turn, continued four wide into the stretch and weakened. NANCY FROM NAIROBI (GB) saved ground chasing the pace, steadied in tight nearing the quarter pole and also weakened. FRESH FELINE stalked outside a rival, bid three deep between horses into the second turn, continued between rivals on that turn and three wide into the stretch and also weakened.
