Dark Bay or Brown Filly, (Mar), by Milwaukee Brew - All Saint's Day by Gold Case. Trainer Pinchin Jose. Bred by Tracy Pinchin (FL).

SINISTER BREW reserved along the inside after bumping with LOK VIRSA at the start, angled outside MONTESSA G in the stretch, then rallied to be up late. WIN GERA LYN rated off the pace, rallied while drifting out in the stretch, then drifted back in while closing for the place and was steadied to avoid bumping SINISTER BREW nearing the wire. MONTESSA G set the pace along the hedge, drew clear racing into the stretch, then drifted in and out while weakening late. LOK VIRSA bumped hard between rivals at the start, chased the pace along the inside to nearing the stretch, then tired. ARABELLA'S TUNE chased the pace off the hedge into the stretch and faltered. MACANUDA failed to menace after bumping hard with LOK VIRSA at the start. PHOEBE MOON steadied entering the first turn and was not a factor. SWEET AND VICIOUS chased the pace for a half mile and faded. ALL AMERICAN STAR was done early. THE RIDER OF WIN GERA LYN LODGED AN OBJECTION AGAINST THE RIDER OF SINISTER BREW FOR ALLEGED INTERFERENCE NEARING THE WIRE. THE CLAIM OF FOUL WAS NOT ALLOWED.
