MR. JORDAN rated just off the pace racing along the rail, angled out at the head of the lane, took over at the eighth pole in hand and pulled away, never asked. MORGANS HARBOUR raced in contention stalking the leader between foes with three furlongs left to run, urged for response approaching the turn, failed to move on, kicked in and rallied five wide in the upper stretch, no match for winner but finished clearly second best. SING PRAISES raced behind the pacesetter throughout the backstretch, edged up and dueled at the head of the lane, took the lead, lost position at the eighth pole and finished evenly in final stages. TWOTWENTYFIVE A settled back off the pace, raced four wide in the upper stretch and passed tiring rivals in the final furlong. LAKOTA WARRIOR away alertly at the start, continued sharp on top leaving the backstretch, challenged and dueled at the head of the lane, could not match strides shortly after and began to weaken. DUKIN' WITH DALE was unhurried racing near the back of the pack in the backstretch, raced five wide at the head of the lane, slightly improved position but needed more to make an impact. FIERCE TIDE rated back off early pace, cut the corner into the lane and failed to move on. HEAR THAT TUNE raced in contention four wide in the backstretch and failed to sustain bid into late stages. VALICO saved ground racing along the inside and failed to respond.
