1 MILE. (Turf) (1.33) STAKES. Purse \$1,000,000 BREEDERS' CUP JUVENILE FILLIES TURF (GRADE II) FOR FILLIES, TWO YEARS OLD. Weight: 122 lbs. \$10,000 to pre-enter, \$20,000 to enter, with guaranteed \$1 million purse including nominator awards of which 54% to the owner of the winner, 18% to second, 9.9% to third, 6% to fourth and 3% to fifth; plus stallion nominator awards of 3% to the winner, 1% to second and 0.55% to third and foal nominator awards of 3% to the winner, 1% to second and 0.55% to third. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at One mile.). (Cloudy 51)

Chestnut Filly, (Apr), by More Than Ready - Miss Seffens by Dehere. Trainer Pletcher A. Todd. Bred by Santucket Stables(KY).

MORE THAN REAL, under snug rating four wide and within range, moved up under confident handling leaving the far turn, swept to command while drifting in some in upper stretch, kicked well clear under right handed pressure a furlong out then held sway under steady handling. **WINTER MEMORIES**, towards the inside around the first turn, angled out a bit and rated forwardly down the backstretch, awaited room nearing the quarter pole, worked through traffic into the stretch to loom boldly, flattened out late but managed to save the place. **KATHMANBLU** was steadied under the wire the first turn, steadied along nearing the backstretch, was shuffled back a bit near the far turn, waited behind rivals approaching the stretch, angled out six wide in upper stretch then finished full of run once straightened. **FOREST LEGEND**, unhurried early while well back through six furlongs, altered out seven wide in upper stretch and closed willingly. **TOGETHER (IRE)** settled back towards the inside, steadied when lacking room into the far turn, angled out leaving the three eighths pole, advanced between rivals nearing the sixteenth marker then continued on with interest. **WYOMIA**, taken to rate three wide, made some progress nearing the quarter pole, altered in for the drive but failed to generate the needed response. **QUIET OASIS (IRE)** stalked the pace while saving ground, moved closer into the stretch, failed to sustain her run then faded in the final furlong. **NEW NORMAL**, allowed to settle off the rail, advanced some nearing the quarter pole then flattened out. **DOS LUNAS** sprinted to a clear early lead, set the pace along the inside, was joined by **FANCY POINT** mid way down the backstretch, duled with that rival to the five sixteenths marker, edged back clear into the lane then faltered in the final furlong. **FANCY POINT** stalked the pace three wide, moved to challenge down the backstretch, duled past the five sixteenths pole, steadied when in close between rivals in upper stretch then gave way. **TALE UNTOLD** saved ground and failed to respond. **ARCH SUPPORT** was steadied when in close entering the first turn, recovered to stalk the pace off the rail, chased between rivals mid way on the final turn then tired in the drive. **ALLURE D'AMOUR**, four wide early, rushed up while getting out very wide nearing the half mile pole, was guided back in under right handed encouragement, circled five wide nearing the quarter pole then gave way. **FLOOD PLAIN (GB)** broke a step slow, raced three wide around the first turn, dropped back entering the lane and was eased through the final furlong. An objection by the rider of **WINTER MEMORIES** against the winner for alleged interference in upper stretch was not allowed
