MORTICIA vied for the lead to the outside of CORBY, shook off that one leaving the turn, dug in to meet the bid of LULL a furlong out, fought on through a long drive but grudgingly gave in. FAIR POINT settled off of the inside, got through entering the stretch, steadied near the quarter pole, was quickly back into stride and advanced between runners. CORBY disputed the pace along the inside, contested the issue to the final furlong and weakened. MISSISSIPPI DELTA was forwardly placed between horses, but lacked a response when called upon. MISS GOSSIP (IRE) contended between horses, shifted out but faltered in the final furlong and faded. SEA CLOUD saved ground to little avail. SCATTER GUN was hustled along four wide through the turn and caved. MARQUEE MISS was within reach five wide for a half and dropped out.
