LULL was reserved off of the pace toward the inside, tipped out and moved up to engage the leaders into the lane, poked her head in front inside the furlong marker, kicked clear and scored with something left. HAPPY MESA was allowed to settle, came five wide to make her bid, quickened in the final furlong and was up in time to earn the place. MORTICIA vied for the lead to the outside of CORBY, shook off that one leaving the turn, dug in to meet the bid of LULL a furlong out, fought on through a long drive but grudgingly gave in. FAIR POINT settled off of the inside, got through entering the stretch, steadied near the quarter pole, was quickly back into stride and advanced between runners. CORBY disputed the pace along the inside, contested the issue to the final furlong and weakened. MISSISSIPPI DELTA was forwardly placed between horses, but lacked a response when called upon. MISS GOSSIP (IRE) contended between horses, shifted out but faltered in the final furlong and faded. SEA CLOUD saved ground to little avail. SCATTER GUN was hustled along four wide through the turn and caved. MARQUEE MISS was within reach five wide for a half and dropped out.
