SALAMA was bumped around early between horses, chased the pace, fanned into the five path entering the lane while making a bid but weakened late in the stretch run. TIZ KISMET was back early, moved up into closer contention, shifted into the four path in the final turn, continued the bid into the lane but faded late in the stretch drive. STREET OF GOLD swung into the six path in the final turn and was empty late in the stretch. ANNULMENT pressed early on, took over command and led the field, angled off the rail into the final turn and gave way in the stretch. WEEKEND WISH was through after a half. SAKONNET POINT had early speed then quickly retreated.
