(GRADE III) FOR THREE-YEAR-OLDS AND UPWARD.* By subscription of \$150 each which shall accompany the nomination and an additional \$1,500 when making entry. The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight: Three-Year-Olds, 123 lbs.; Older, 124 lbs. BEAR TOUGH TIGER raced in midpack, angled out chasing on the turn, rallied five-wide, bid a furlong out and prevailed under steady handling. BEAR NO JOKE stalked the pace, chased four-wide late turn, bid a furlong out, dueled but was outfinished. SOMETHING EXTRA forced the issue, bid in earnest late turn, dueled into the stretch but gave way grudgingly after being headed by the top two finishers. COURT OF THE REALM raced off the pace, was hustled two-wide on the turn, was blocked upper stretch then finished gamely in vain. ESSENCE HIT MAN set a very pressured pace, was engaged late turn, dueled into the stretch and gave way in the final furlong. NIGHT OFFICER settled off the pace, was hustled four-wide on the turn then finished evenly. HAVELOCK, rated off the pace, was hustled three-wide on the turn then evened out in the stretch. FATAL BULLET raced in midpack, chased six-wide late turn and evened out in the stretch. ARTIC FERN settled off the pace, was hustled three to six-wide through the turn but was never in contention.
