By subscription of \$100 each, which shall accompany the nomination; \$1,250 to enter and \$1,750 to start. Supplemental nominations of \$3,500 will be accepted at time of entry and shall include all other fees due as noted. \$200,000 Guaranteed, of which to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight; 122 lbs. Non-Winners of \$90,000 at a mile or over on the turf since May 14th, 2018 allowed 2 lbs.; \$60,000 at a mile or over on the turf since April 14th, 2018, 4 lbs.; \$40,000 at a mile or over in 2018, 6 lbs. (Maiden, claiming and starter races not considered in estimating allowances.) Trophy to the Winning Owner, Trainer and Jockey. Nominations Closed Saturday, June 30, 2018 with 20 nominations. (If deemed inadvisable by management not to run this race over the turf course, it will be run on the main track at One Mile and One Eighth). (Clear 87)

GOLDEN BROWN was well placed just off the pace and moved up between horses on the far turn, ran down the leaders in the final furlong and edged clear. HOT SPRINGS, well placed close to the pace, was crowded into UNTAMED DOMAIN in upper stretch and continued gamely. CARRICK was stoutly restrained from bearing out early then responded well in the drive. ARCHAGGELOS broke sharp to set the pace, then drifted in crowding HOT SPRINGS into UNTAMED DOMAIN in upper stretch. WAY EARLY was forwardly placed then responded well in the drive. UNTAMED DOMAIN was checked along the inside on the far turn then again in tight quarters along the inside rail in upper stretch. GUNNISON lacked the needed rally. DUC DE CALAS (FR) was checked on heels in midstretch. ARCHAGGELOS was disqualified to sixth for interference in the stretch following a stewards inquiry and objection by the rider of UNTAMED DOMAIN.
