1 1/2 MILES. (Turf) (1.471) STAKES. Purse \$500,000 (Includes \$100,000 BC - Breeders' Cup) *KENT BREEDERS CUP S.(GRADE III) FOR THREE YEAR OLDS.* By subscription of \$500 each, which shall accompany the nomination; \$2,000 to enter and \$2,500 to start. Supplemental nominations of \$6,000 will be accepted at time of entry and shall include all fees. \$500,000 Guaranteed \*(include s \$100,000 from Breeders' Cup fund for cup nominees only). The host association's money to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Any Breeders' Cup fund monies not awarded reverts back to the fund. Weig ht; 122 lbs. Non-Winners of \$120,000 at a mile or over since July 2, allowed 2 lbs.; \$90,000 at a mile or over since May 2 , 4 lbs.; \$45,000 at a mile or over since April 2, 6 lbs. (Maiden and Claiming races not considered in estimating allowances.) St arters to pass the entry box by the usual time of closing. Preference given to Breeders' Cup nominees only of equal racing quality or which have accumulated the highest total earnings. The winner to receive a trophy from Breeders' Cup Limited. Closed Sa turday, August 19th, 2006 with 31 nominations. (If deemed inadvisable by management not to run this race over the turf course, it will be run on the main track at One Mile and One Eighth).

CARNERA moved up along the inside around the far turn then was no match for the winner in the stretch. SEA OF TREES was unhurried early then rallied mildly to gain the show late. SPIDER POWER (IRE) failed to menace with a mild bid through the stretch. KIP DEVILLE stalked the pace racing just outside the leader then weakened in drive. PRESIOUS PASSION was forwardly placed for six furlongs then weakened in the drive. MERCURIUS showed little. SILENT ROAR lacked a rally. DIABOLICAL broke alertly and saved ground setting the pace to the stretch then had nothing left. AFTER MARKET raced within easy striking distance early then offered no response. Portable inner rail set at zero.
