Dark Bay or Brown Gelding, (Mar), by Last Lion - April Mom by L'Enjoleur. Trainer Gutierrez Jorge. Bred by Elmer Ramos(CA). MR. WOLVERINE content to track leaders while slightly off the rail to second bend, advanced and engaged rivals three deep into the stretch, gained control and edged away under urging outside. EPIC POWER stepped to front and set pressured pace from along the rail, resisted inside when challenged, could not match winner late but gamely held the place. LAVA MAN forced the pace outside rival into the second bend, moved up and challenged from between rivals entering the lane but lacked the needed late punch in the drive. TOP THIS AND THAT reserved off the pace and angled in entering the backstretch, saved ground into the lane but failed to seriously threaten. DAWN'S EARLY SKY settled inside early then chased on two wide path into the stretch and failed to make any late impact. CELTIC DREAMIN unhurried leaving the gate, chased off the rail then inside to the stretch, came out some in the lane but never reached contention.
