**1 MILE. (Turf) (1.313) STAKES. Purse \$350,000 FRANK E. KILROE MILE S. (GRADE I) FOR FOUR-YEAR-OLDS AND UPWARD. By subscription of \$100 each to accompany the nomination, closed with 19. Or by supplementary nomination of \$7,000 by time of entry, closed with 2. \$750 to enter, \$4,500 additional to start, with \$350,000 guaranteed, of which \$210,000 to first, \$70,000 to second, \$42,000 to third, \$21,000 to fourth and \$7,000 to fifth 123 lbs. Non-winners of a Grade I race at One Mile or Over since September 7, 2013, allowed 3 lbs.; Non-winners of a Grade I race at One Mile or Over OR Two Grade II races since March 7, 2013, allowed 5 lbs. A trophy will be presented to the winning owner. (Clear 82)**

**WINNING PRIZE (ARG)** had good early speed and angled in, set a pressured pace a bit off the rail, battled outside the runner-up leaving the second turn and through the stretch and gamely prevailed under urging. **LOCHTE** pulled along the inside early, saved ground stalking the pace, bid along the rail leaving the second turn and through the stretch and continued willingly to the wire. **SUGGESTIVE BOY (ARG)** broke a bit slowly, angled in and chased outside a rival, went three deep on the second turn and five wide into the stretch and finished well. **ZA APPROVAL** saved ground stalking the pace, came a bit off the rail in deep stretch and lost third late. **SILENTIO** chased outside a rival, came out on the second turn and four wide into the stretch and was outfinised. **LAKERVILLE** broke a bit slowly, settled outside a rival then off the rail, came out in the stretch and lacked the needed rally. **TOM'S TRIBUTE** stalked early, bid outside the winner on the backstretch and into the second turn, dropped back between foes leaving that turn and weakened. **REGALLY READY** stalked between horses, bid three deep leaving the backstretch and on the second turn and also weakened. **OPTIMIZER** rank and steadied early, saved ground off the pace, came out into the stretch and did not rally.
