About 7½ FURLONGS. (Turf) (1:27<sup>3</sup>) STAKES. Purse \$100,000 Kitten's Joy S. THREE YEAR OLDS. Free nomination by Sunday, December 23. \$1,000 to enter. \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 122 lbs. Non-winners of a graded stakes on turf allowed 2 lbs.; a stakes race, 4 lbs.; two races other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. Preference will be given to graded stakes winners, then by highest career earnings. In the event this race is taken off turf, it will be run at seven furlongs. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at Seven Furlongs) (Rail at 12 feet). (Cloudy 72)

Bay Colt, (Mar), by Jimmy Creed - Achalaya by Bellamy Road. Trainer William I. Mott. Bred by Silver Springs Stud, LLC (KY).  
 CASA CREED raced in stalking position just off leader in backstretch, edged up and applied pressure to ROYAL URN three furlongs out, vied for lead with rival holding head in front at quarter pole then rival shook free briefly top stretch, quickly roused back up to challenge for lead, dueled outside of ROYAL URN then dug in gamely outside path and got up late. HENLEY'S JOY steadied slight entering first turn then rated off comfortable pace being set on top, made move taking closer order late final turn, shifted out wider top stretch and set down for drive, kicked in determinedly and gained to wire. ROYAL URN set comfortable pace saving ground through backstretch, came under pressure from eventual winner in final turn and held slim lead, roused forward top stretch then dueled with edge over CASA CREED in final furlong, fought back along inside then lacked final kick. LOUDER THAN BOMBS settled midpack in backstretch, took closer order racing four wide leaving final turn, under strong right handed drive and came in couple paths, raced in contention then lacked closing bid. MOON COLONY raced off pace, swung wide into top stretch and finished with response. STIRLING DRIVE saved ground through backstretch, raced in contention along rail at quarter pole, cut corner entering top stretch then switched out path, kept on with response then evened out. BOURBON IN MAY stalked through backstretch, made three wide bid gaining close contention in turn, kept on and raced between rivals a furlong out then flattened. SHAZIER unhurried out of gate, raced in the back through backstretch, came under ride racing near inside in final turn, kept under steady urging upper stretch but failed to respond. DAKOTA'S DUDE raced off the pace, hustled up in final turn but failed to move into contention.
